

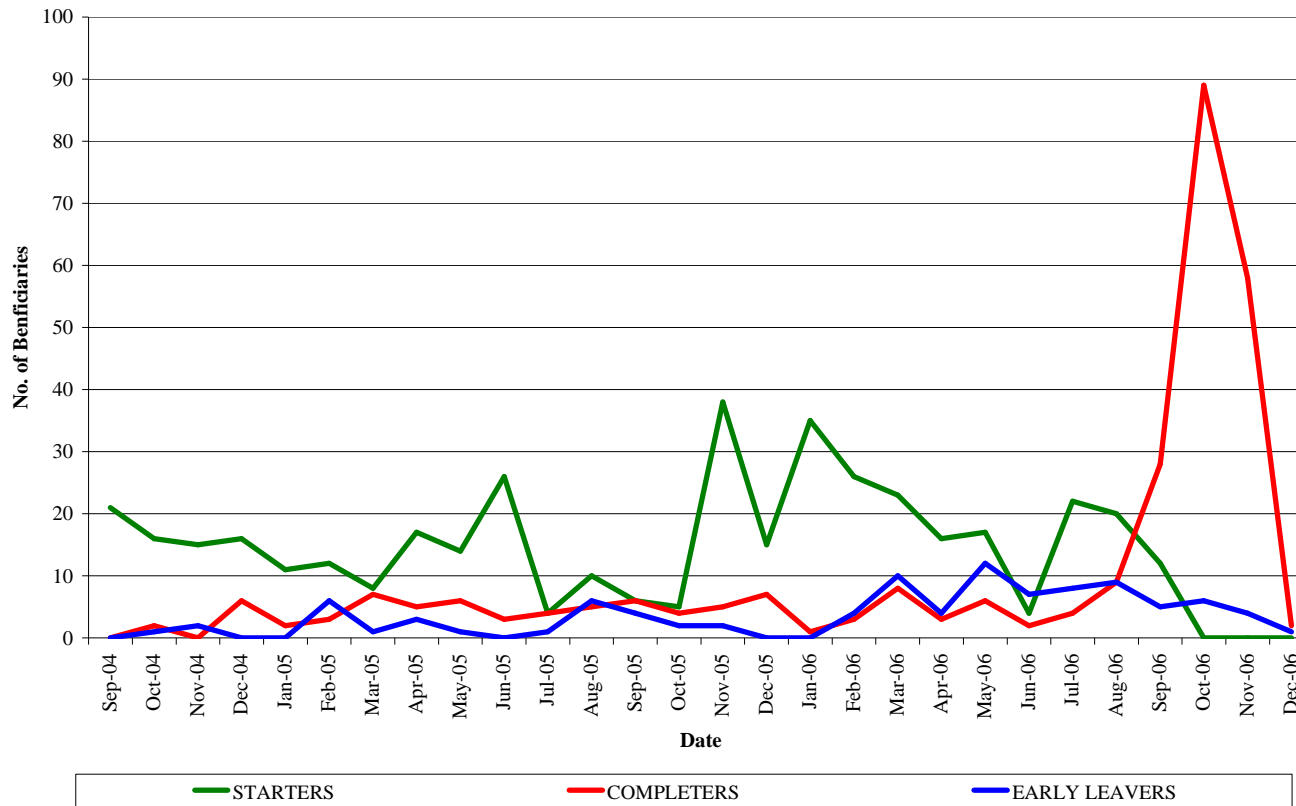

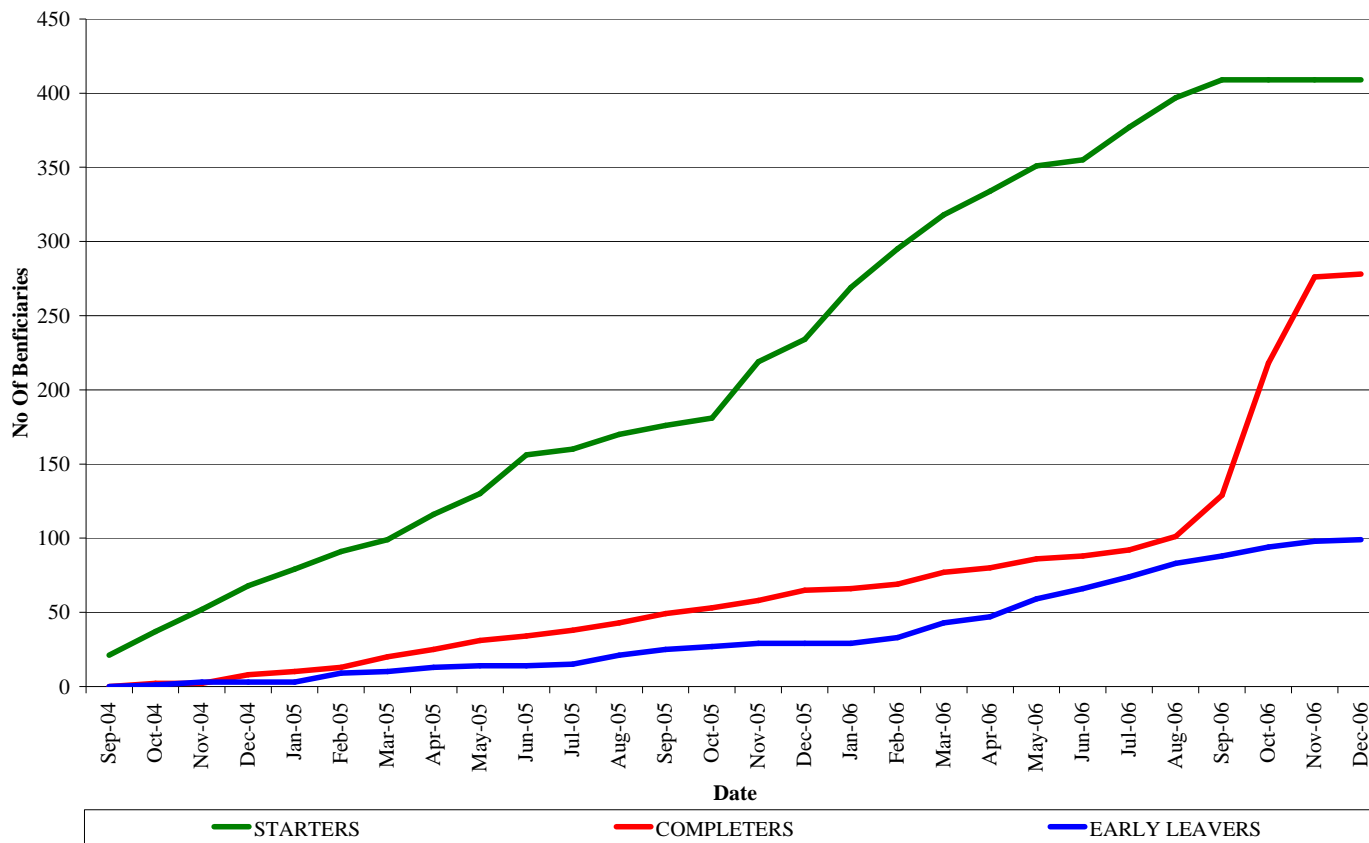

Starters, Completers and Early Leavers Per Month



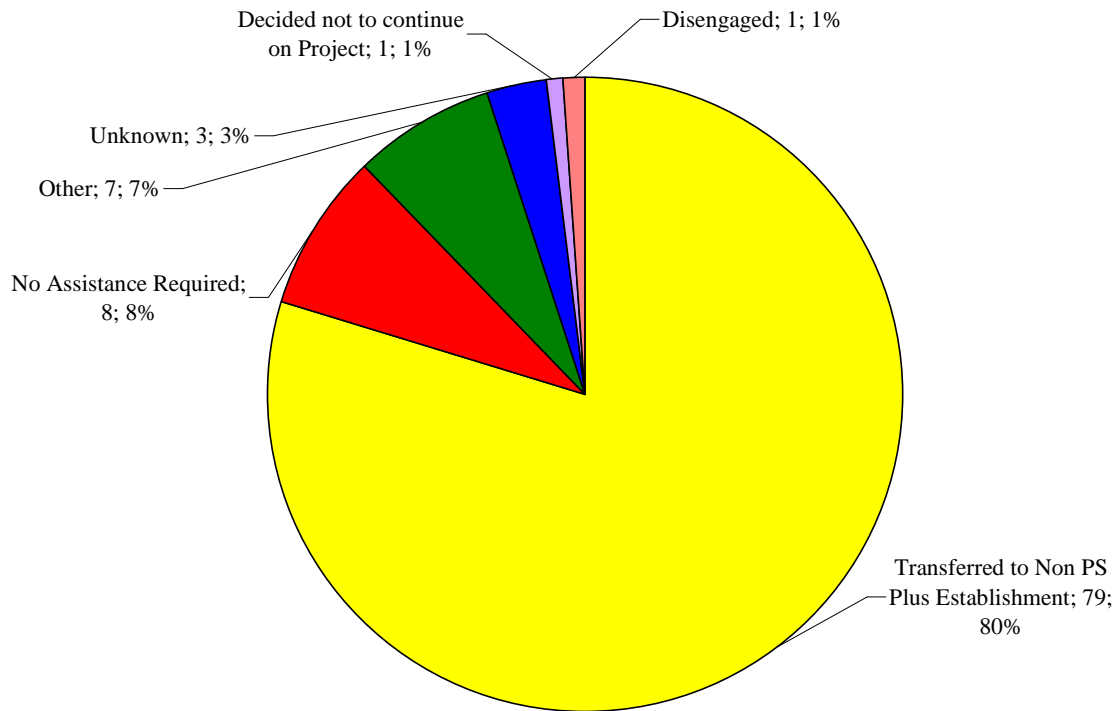
- Most months, Garth started between 10 and 25 beneficiaries on the PS Plus 2 project.
- Up until the last 4 months of the project, no more than 15 beneficiaries were completing or leaving the PS Plus 2 project early per month.

Cumulative Starters, Completers and Early Leavers



- Over 400 beneficiaries were started on PS Plus 2 in Garth.
- 377 beneficiaries finished in Garth – 278 completed the project and 99 left the project early.

Reasons for Early Leavers

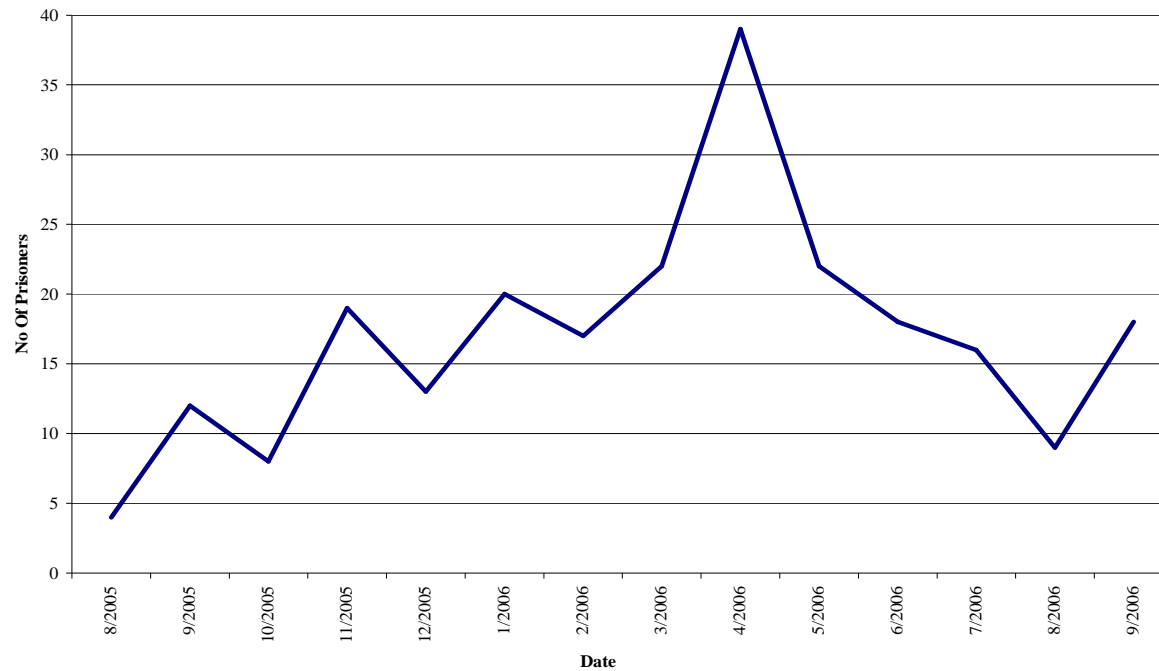


Other reasons given for beneficiaries leaving the project early:

- Of the 99 beneficiaries who left the project early, 80% (79) transferred to a Non-PS Plus establishment.
- 8% (8) of early leavers did not require any assistance from PS Plus.
- One beneficiary decided not to continue on the PS Plus project.

Non-Starters Per Month



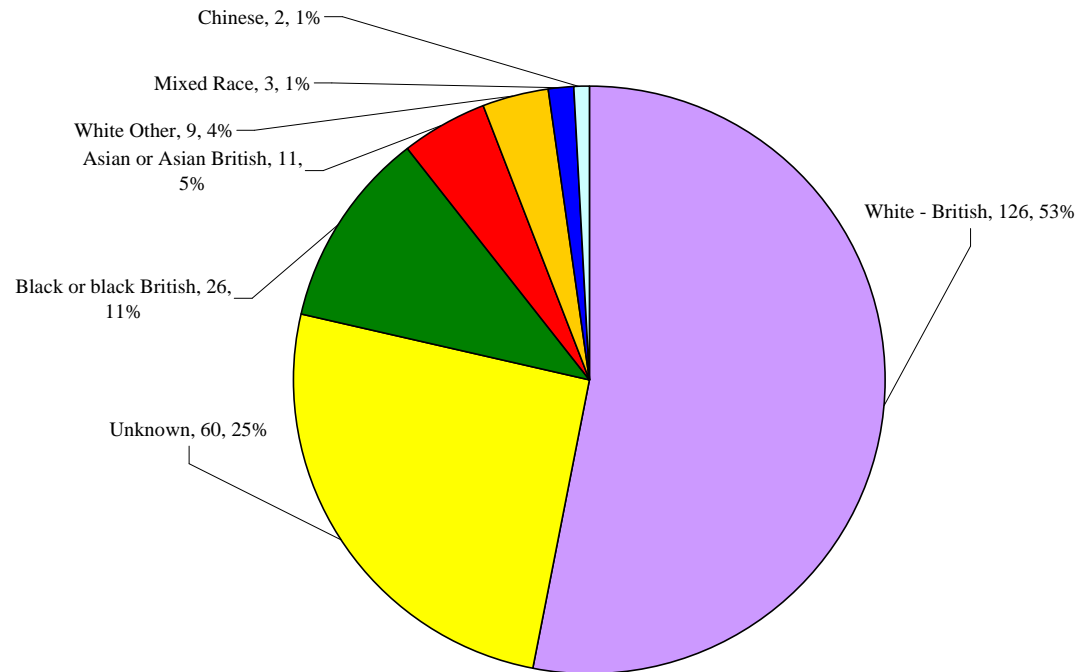

- Most months, fewer than 20 prisoners were seen and deemed unsuitable for the project.
- In total, 237 prisoners were not started on the PS Plus 2 project in Garth.
- 78 prisoners did not require PS Plus services and 60 prisoners had no interest in the project.

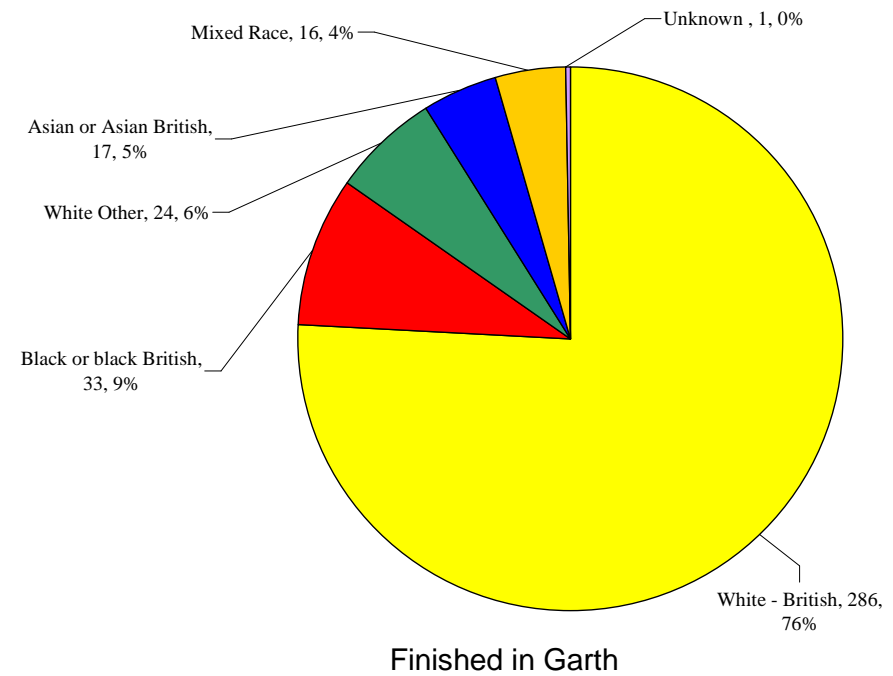
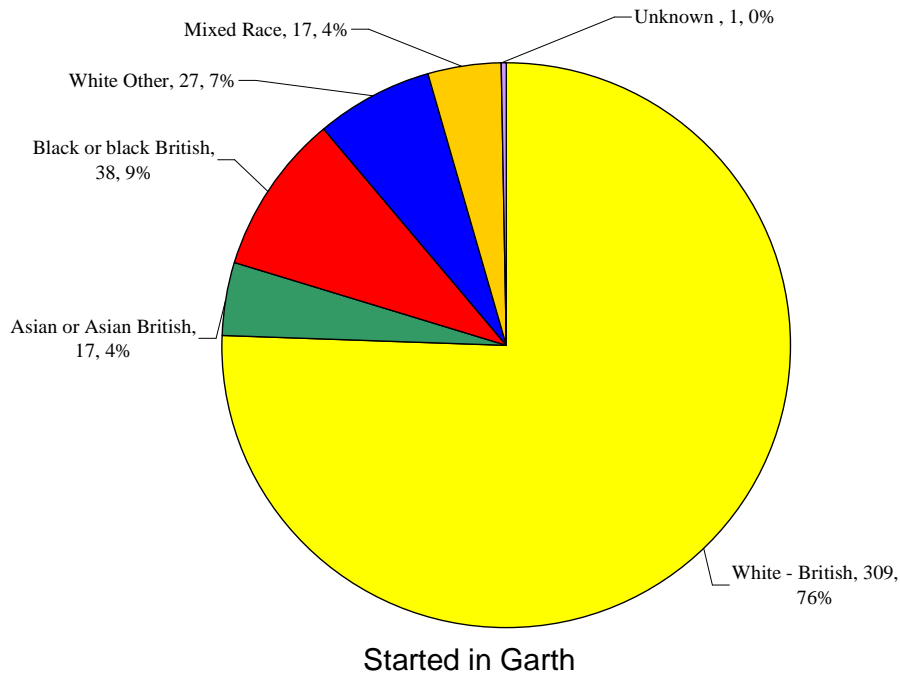

- The majority of the prisoners not started on the PS Plus project were White-British (53%) and from United Kingdom (77%).
- The ethnic origin for 1 in 4 and the nationality of 1 in 8 of the prisoners not started was unknown.
- Ethnic minorities account for 22% (51 prisoners) of the prisoners not started.

Beneficiaries Started On PS Plus

Ethnic Breakdown of Beneficiaries in Garth



- 76% (309) of the beneficiaries started and 76% (286) of the beneficiaries who finished in Garth were White-British.
- 24% (99) of the beneficiaries started and 24% (90) of the beneficiaries who finished in Garth were from ethnic minorities.
- The ethnic origin of one beneficiary who started and one beneficiary who finished in Garth is unknown.

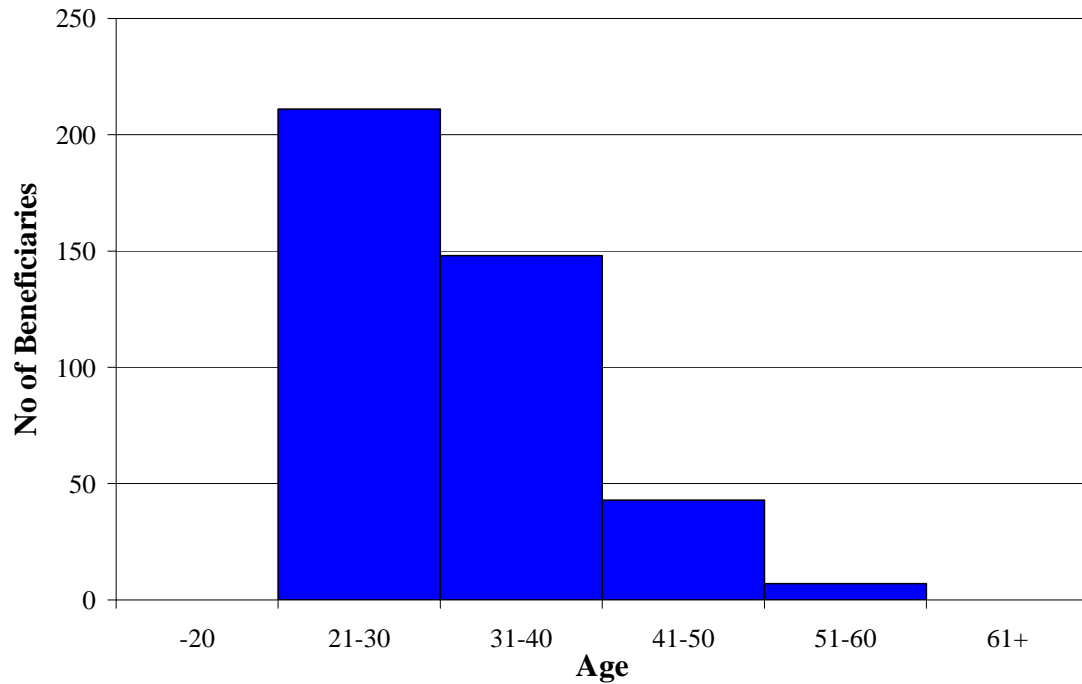

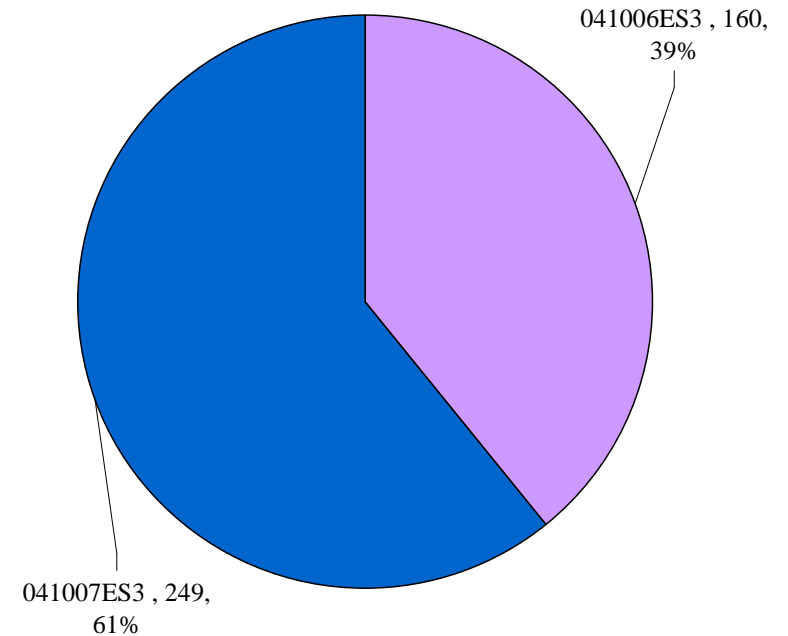

- 83% (341) of the beneficiaries who started in Garth stated that their nationality is United Kingdom, British or English.
- 82% (310) of the beneficiaries who finished in Garth stated that their nationality is United Kingdom, British or English.
- The nationality of 64 of the beneficiaries started in Garth and 62 beneficiaries that finished in Garth was unknown.

Age and Dossier Number of Beneficiaries on Starting PS Plus 2



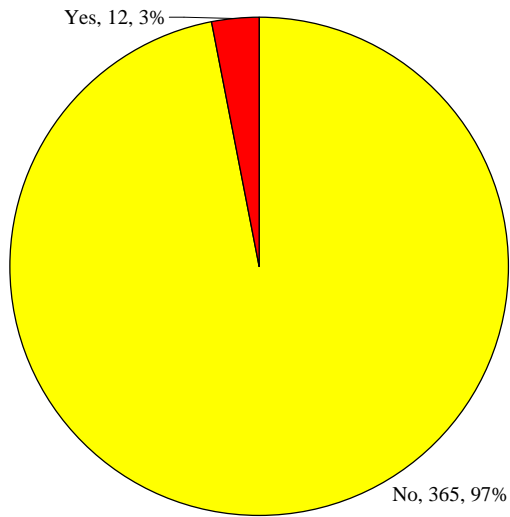
Age Breakdown



Dossier Number Breakdown

- The average (mean) age of the beneficiaries started in Garth is 31 years and 5 months. The average (mode) age group is 21 – 30 years old.
- There were no beneficiaries in Garth under the age of 21 or over the age of 61.
- 61% (249) of the beneficiaries were in the ESF Group 041007ES3 (male beneficiaries aged 28 and over).

Disabled Beneficiaries



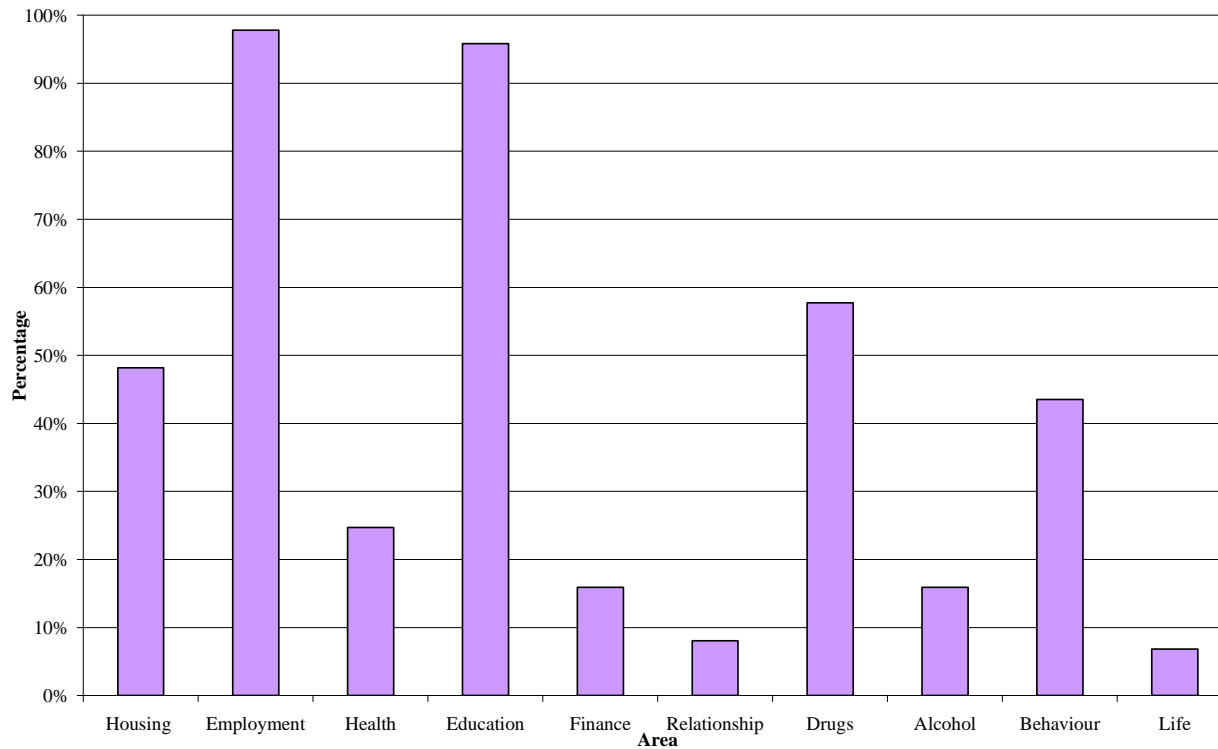

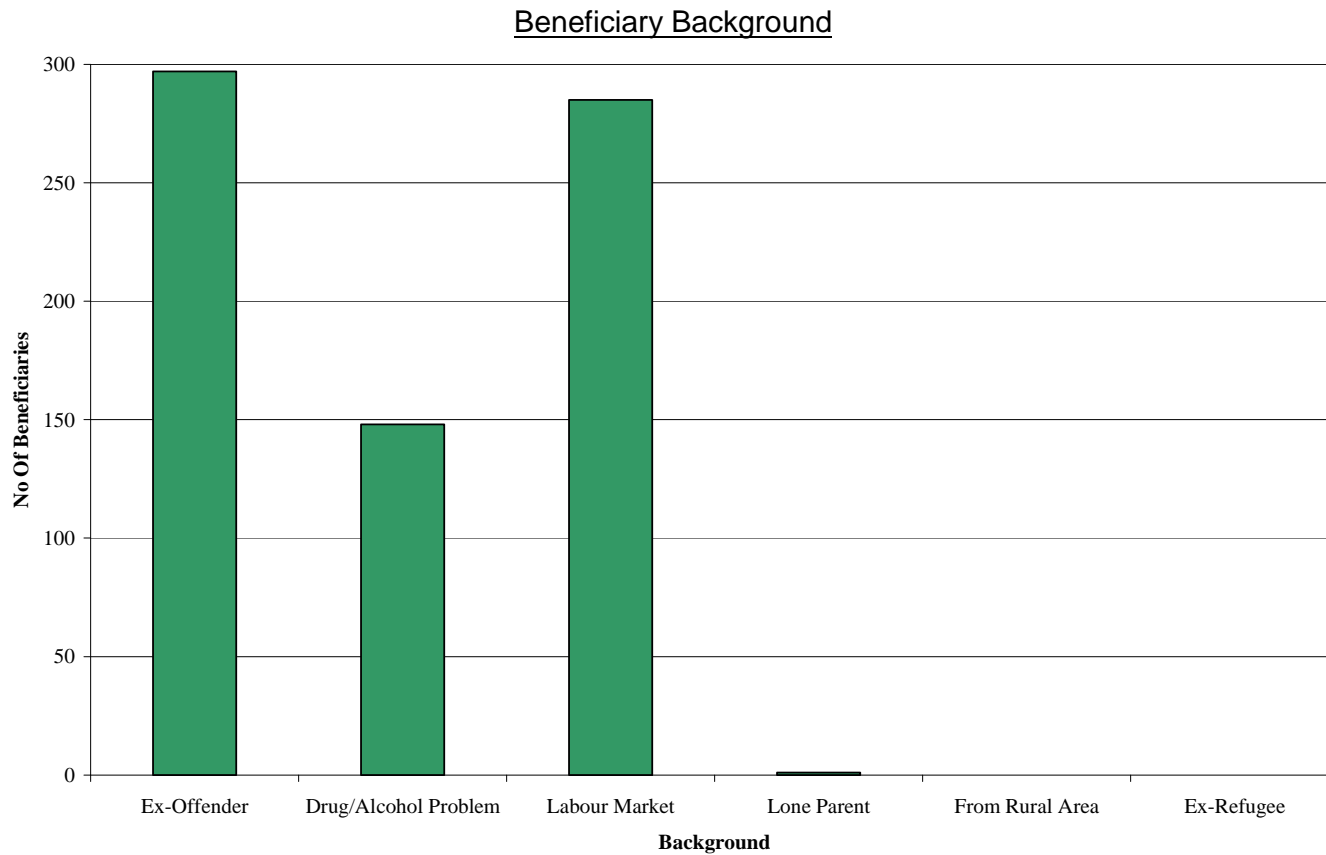
Beneficiaries Finishing in Garth

- 3% (12 of the beneficiaries who started in Garth were classified as being disabled.
- 3% (14) of the beneficiaries who finished in Garth were classified as being disabled.

Needs of the Beneficiaries Started in Garth



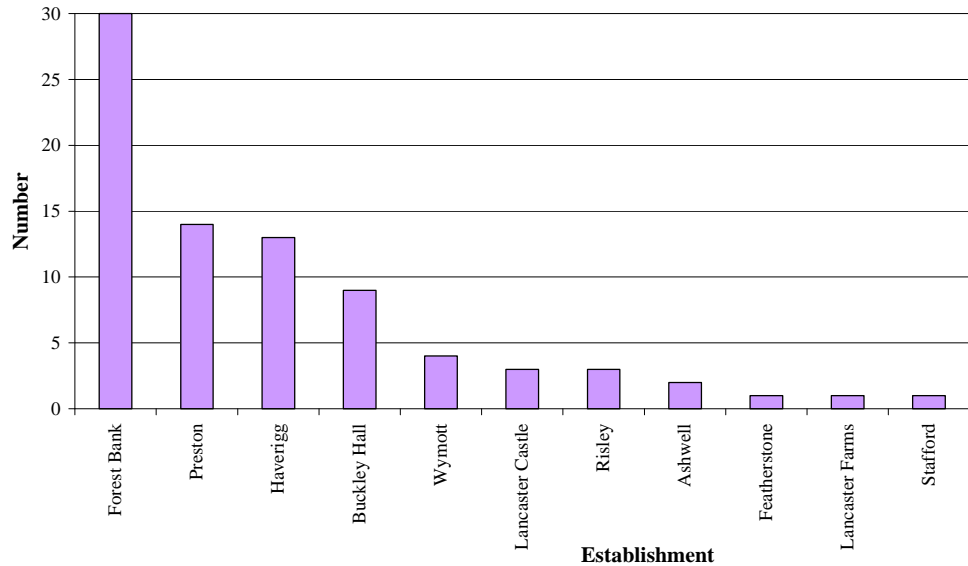
- Over 95% of the beneficiaries who started in Garth needed help with employment and over 95% needed help with education.
- Over 55% of the beneficiaries who started in Garth needed help with drug issues.
- Over 40% of the beneficiaries who started in Garth needed help with housing issues.



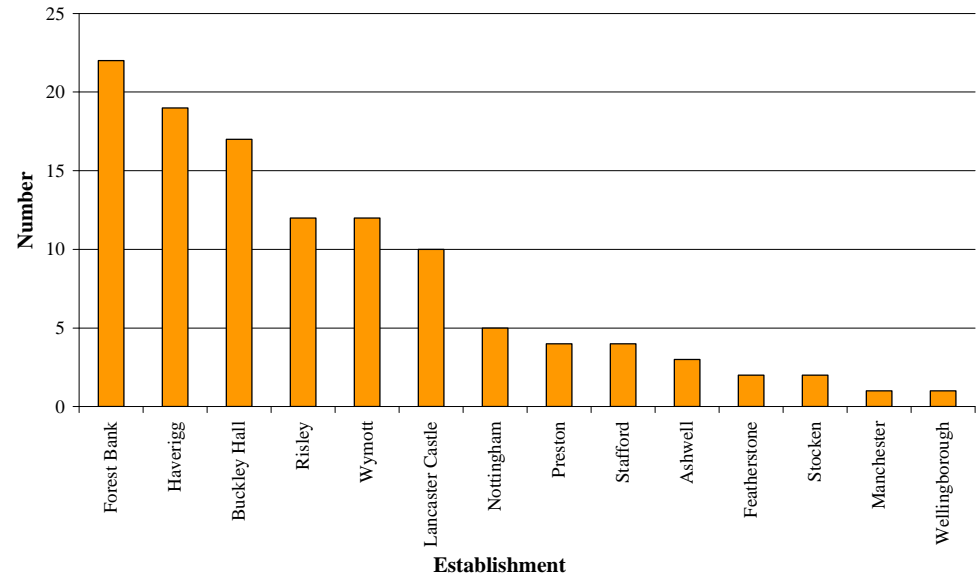
- Over 280 of the beneficiaries who started in Garth were ex-offenders.
- Nearly 150 of the beneficiaries who started in Garth had a drug or alcohol problem.

Transfers into Garth

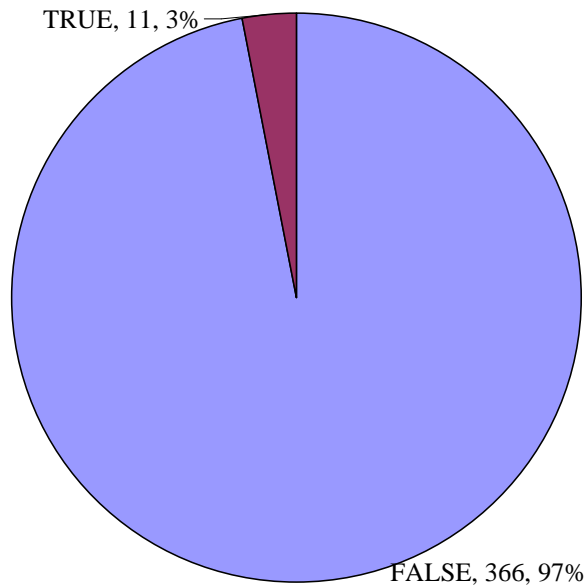

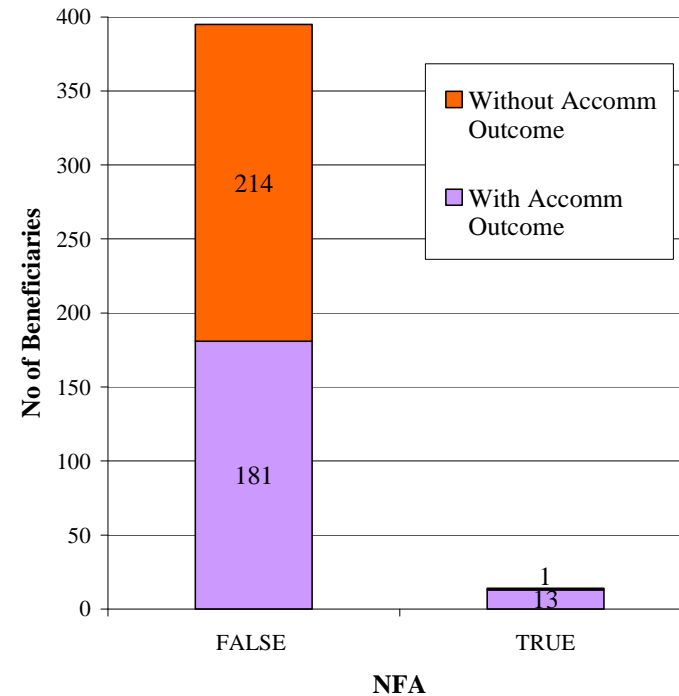


- 81 beneficiaries have transferred into Garth – 81% transferred to Garth from Forest Bank, Preston, Haverigg or Buckley Hall.
- 114 beneficiaries have transferred from Garth – 81% transferred from Garth to Forest Bank, Haverigg, Buckley Hall, Risley, Wymott or Lancaster Castle.

Beneficiaries that have No Fixed Abode

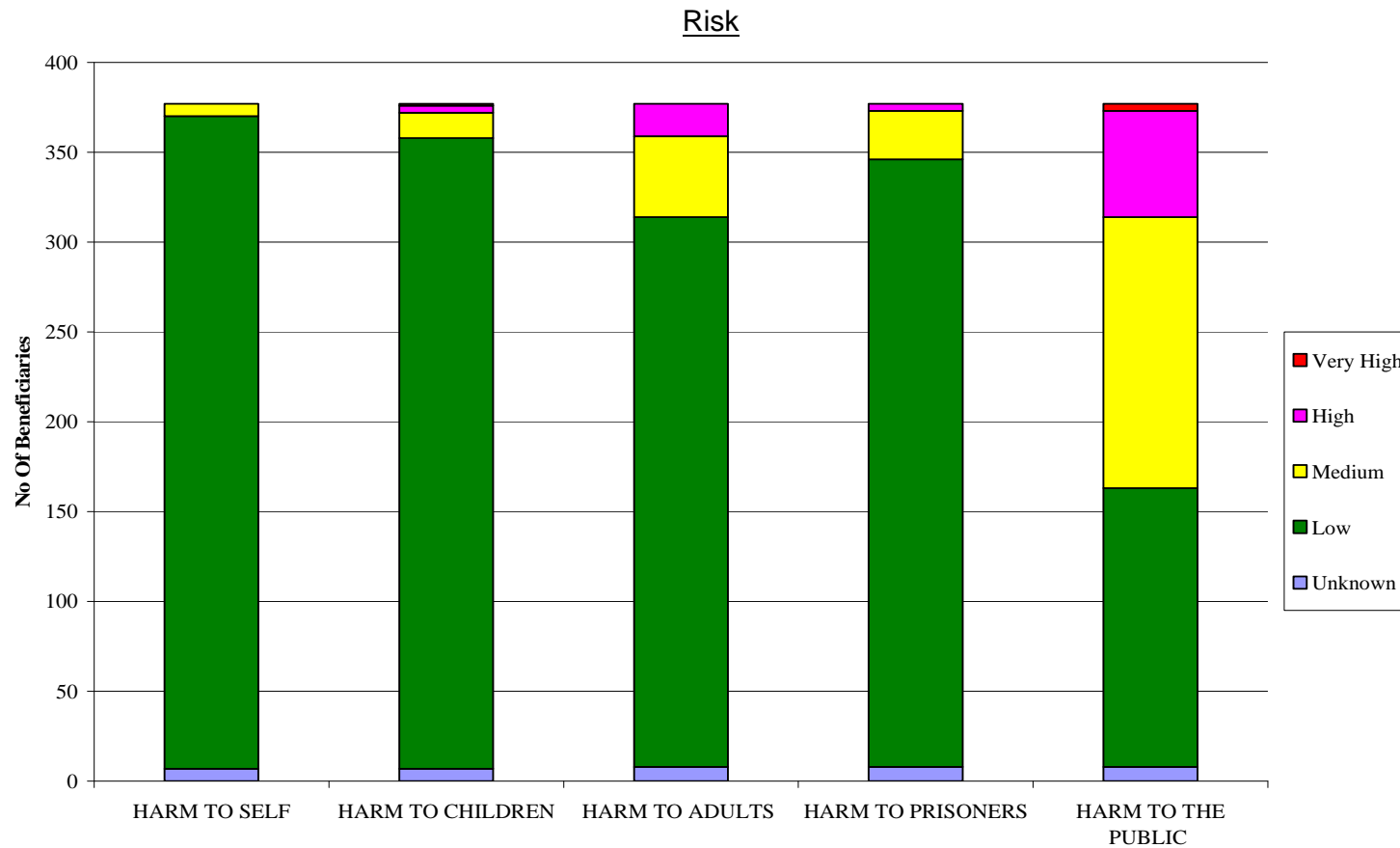


Beneficiaries Starting in Garth



Beneficiaries Finishing in Garth

- 3% (11) of the beneficiaries started in Garth were classed as having no fixed abode on starting the project.
- 14 beneficiaries were classed as having no fixed abode on finishing the project. Of these, 13 had an accommodation outcome secured.



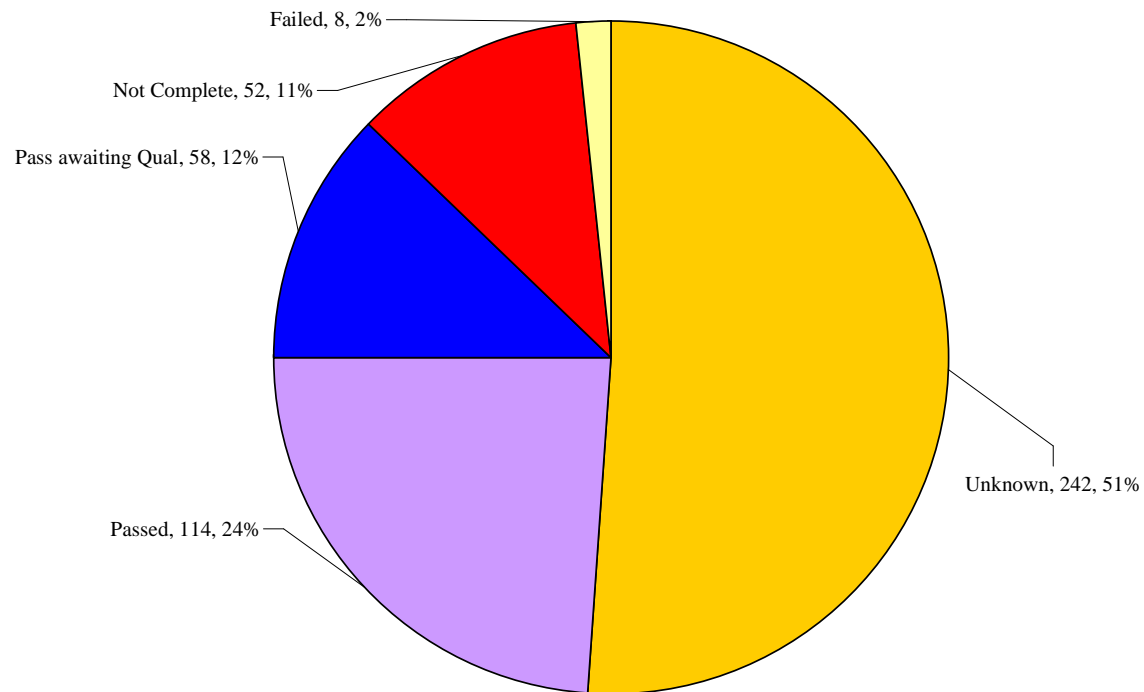
- 57% of the beneficiaries in Garth were of medium, high or very high risk to the public.
- The majority of the beneficiaries were of low risk to themselves, children, adults and other prisoners.

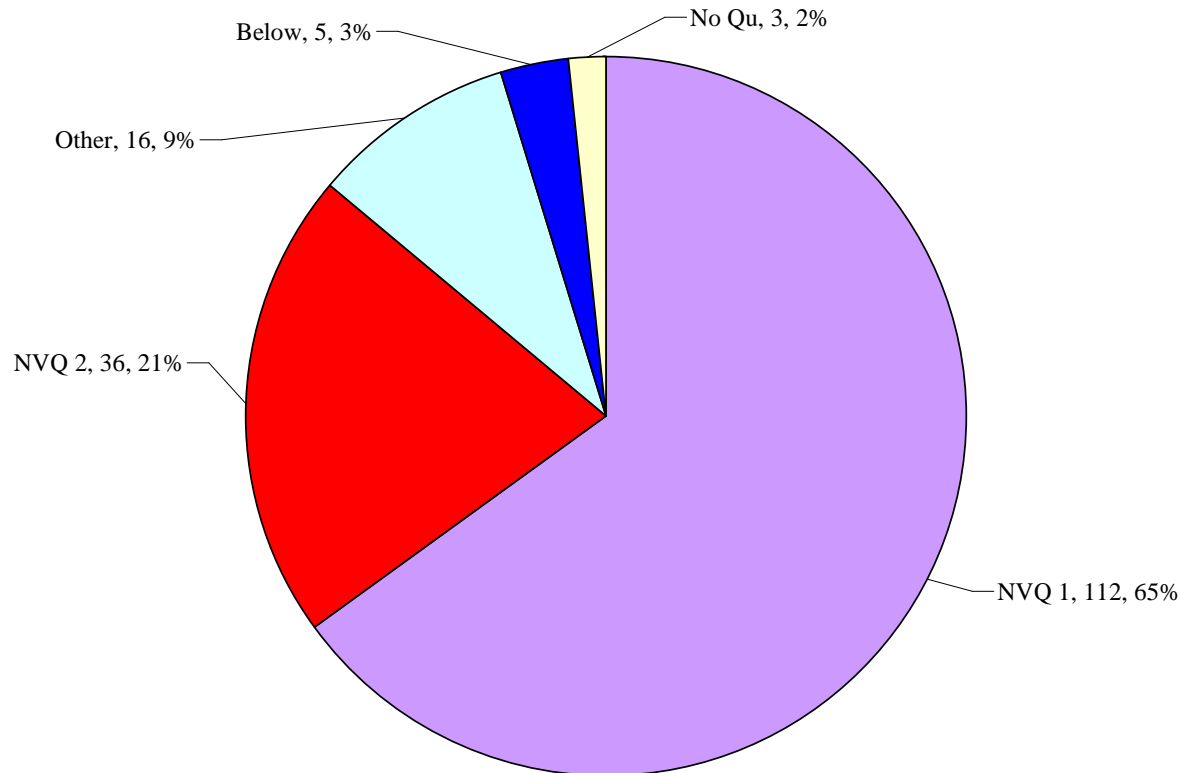
- 315 soft outcomes were gained by Garth beneficiaries.
- 137 beneficiaries had IAG assistance.
- 56 beneficiaries attended ECDL.
- Beneficiaries in Garth attended 20 interviews – Fresh Start, Job, New Deal and Progress to Work interviews.
- One beneficiary utilised the Beneficiary Access Fund.

Exam Results



- In 51% (242) of the exams taken, the outcome is unknown.
- 36% (172) of the exams were passed or passed awaiting qualification.
- Only 2% (8) exams were failed.

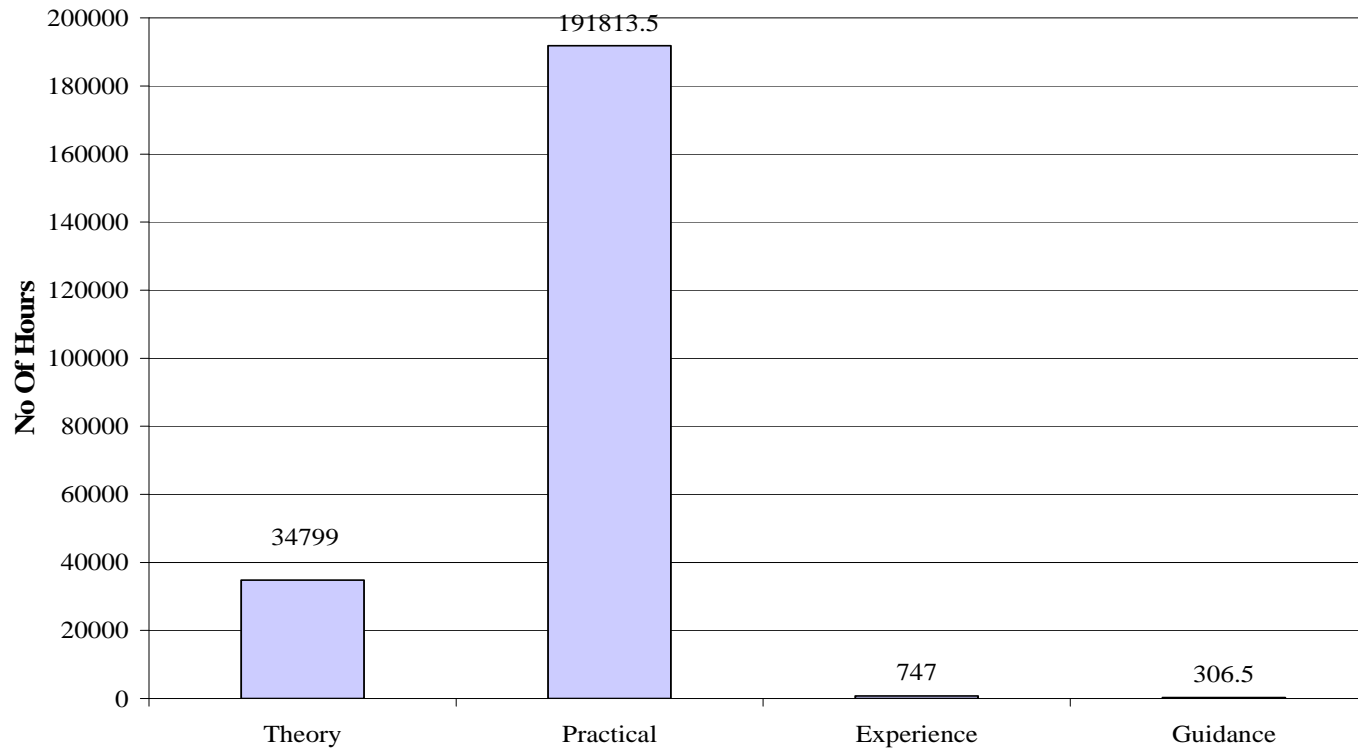

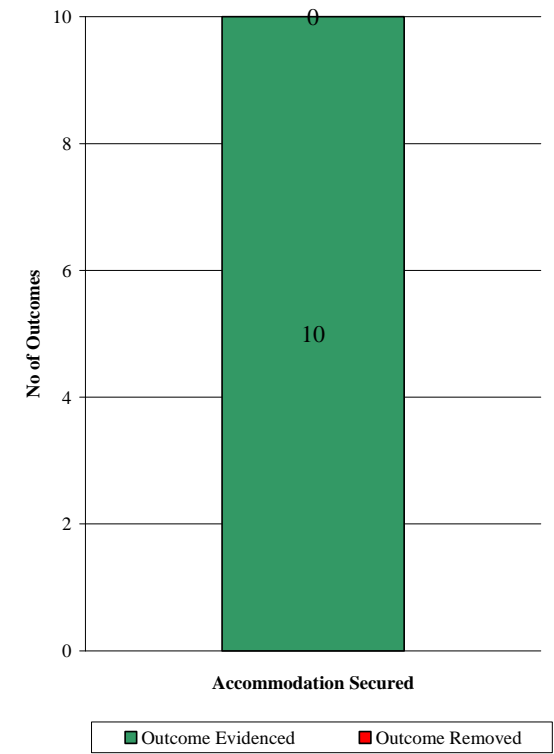
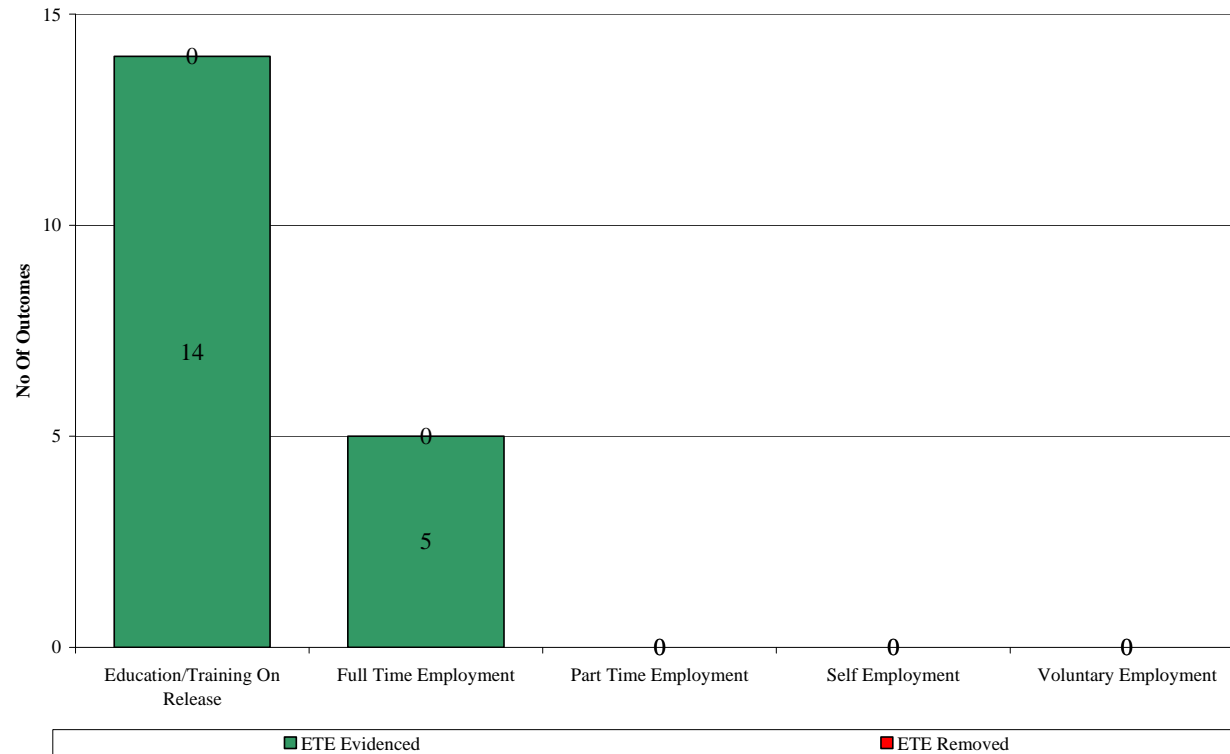
- 148 NVQ levels 1 and 2 have been gained by beneficiaries in Garth.
- 32 adult Literacy and numeracy courses have been passed by beneficiaries in Garth.

Timesheet Hours



- 227,666 hours were collected from PS Plus beneficiaries.
- 191,814 (84%) of the hours collected were for practical activities.

Hard Outcomes



- 19 hard education, training and employment (ETE) outcomes have been recorded at Garth with evidence for all of these outcomes (100% evidence for outcome rate).
- 10 hard accommodation outcomes have been recorded all with evidence (100% evidence for outcome rate).
